

This memorandum of understanding (MOU) is entered on December 1<sup>st</sup>, 2019 between APPNA-PUN (Delaware Valley chapter of Association of Physicians of Pakistani Descent, a not-for-profit organization) and the recognized 501c(3) organization, Cherry Hill Free Clinic (henceforth referred to as CHFC) .

APPNA-PUN being located at 8 manor House Ct, Cherry Hill, NJ 08003 and Cherry Hill Free Clinic located at 5 Easterbrook Ln., Cherry Hill, NJ 08002.

The purpose of this memorandum of understanding is to establish a working affiliation between Cherry Hill Free Clinic and APPNA -PUN, where the latter will provide assistance with volunteers including physicians, nurse practitioners, physician assistants, medical students, non-medical personnel etc. to help with the functioning of Cherry Hill Free Health Clinic. APPNA-PUN may also provide financial assistance, if and when such resources are available and needed.

APPNA-PUN Physicians will also do didactic presentations, workshops where needed and possible.

APPNA-PUN volunteers will be rendering services solely or in conjunction with other volunteers working at CHFC

That APPNA-PUN agrees that it will exercise the highest level of care in using the resources of Cherry Hill Free Clinic and will prevent any misuse of the resources.



That APPNA-PUN agrees that it will exercise the highest level of care in volunteering and using the resources of Muslims Serve and will prevent any misuse of its resources.




either party upon written notice with immediate effect, which shall be delivered electronically, by hand or by certified mail to the address listed above.


